Led by former law enforcement members, this course will demonstrate how to integrate a cloud based commercial LPR data platform into the existing traditional law enforcement deployment of LPR technology.

While you will learn about all currently available LPR systems, this course will mostly focus on the Motorola Solutions LPR database, Vigilant VehicleManager. You will see firsthand how using billions of plate detections can maximize investigative efforts in almost every facet of the job, including both areas of proactive field enforcement and investigations, assisting law enforcement in generating leads to reduce crime and keep communities safe.

This course will include:

- A walk-through of Vigilant Vehicle Manager, where you will learn how to query fixed, mobile and LPR Data to generate case-solving leads.
- An overview of relevant Case Law and Best Practices Demo of basic website navigation and Vigilant Vehicle Manager tools; License Plate Query, Locate Analysis and Stakeout.
- How to generate advanced analytical reports such as Common Plate Analysis, Associate Analysis and Geo-Fence LPR querying.
- Available Investigative resources to assist and enhance your LPR searches.

In this course, you will be working through real-world scenarios with hands-on exercises, utilizing the Vigilant VehicleManager databases, including all the analytics & tools with step-by-step instruction. At the conclusion of this class, each attendee will retain access to Vigilant VehicleManager with login credentials for 30 days.
